Sir/Madam,

From 22nd June to 13th July 2019 on both the Wari Marg, under the Clean Wari-Swastha Wari-Nirmal Wari-Harit Wari Abhiyan, complete cleaning of Wari Marg, distribution of 50 lakh leaves, collection of 750 tons of wet waste and sewage, 350 tons of organic manure, 35 lakh liters of water. Savings, distribution of services and equipment from the health camp of 2 lakh Warkaris. The NSS Department of the University has set a target to make this campaign a success at the level of 2 lakh Warkaris and villagers, planting and cultivating 20,000 neem saplings on the Wari Marg.

Subject: - Regarding filling special camp online proposal.


Sir/Madam,

The academic year 2019-20 marks the 150th anniversary of Mahatma Gandhi's birth and this year Savitribai Phule Pune University has decided to make structural changes in NSS Special Camps. Instead of one college being adopted by one college, 3 colleges should come together and select a village by consensus and it is expected to hold a special 7-day camp in these villages. In that connection, three to four colleges have to adopt a village and review the development work of the adopted village and organize the activities decided by the university. Please note that it is important for the National Service Planning Units in all the three colleges to make this year's subject wise student participation, special camp organizing extremely neat, ubiquitous and more effective. The three colleges should come together as per their agreement and give the coordination of the camp to the college which has more NSS volunteers and / or there is no problem for the three colleges to coordinate together and independently. You have been informed about this in the meetings at the beginning of the year.

This year, each National Service Plan unit is required to conduct this 7-day special camp from December 2019 to February 2020. Proposals are being invited from each National Service Scheme for this special camp. These proposals are being invited online and National Service Planning Units are required to submit online proposals between November 30 and December 7, 2019. For this, www.unipune.asai.in/bcud/login/nss/ special camp proposal link has been made available. Camp proposal online link will not be made available after 7th December 2019. However, the proposal should be filled within the stipulated period.

According to the new provision in the proposal on the website, it is necessary to mention with you the names of at least 2 colleges which have organized special camps in the same village together or back and forth and also attached a letter from the administration of that village allowing

the three colleges to organize camps. It should also be noted that the special camp proposal cannot be filled unless the previous two quarterly reports are filled online.

The first installment of the special camp will be given only to the colleges which are present in the planning meeting in December 2019 and submit online proposals in the above period. It should be noted that the camp proposal should be received through the college and without that the colleges should not organize special camps and also the first installment of the camp cannot be given to the colleges.

While selecting the adopted village, arrangements should be made for the campers of the three colleges to work together or in stages and stay at the residence by talking to the village office bearers. The selection criteria of a village should be strictly followed. We have already informed you that in the next two to three to five years, it will be possible to work on a variety of development and conservation in that village, and the convening college should select the village in which such achievements and natural needs will be observed.



Subject: Relief and rehabilitation work for flood and drought affected groups in Maharashtra

Sir,

Due to heavy rains and floods, life in most parts of Kolhapur and Sangli has been disrupted. There has been immense damage to natural and human property. Against this backdrop, under the direction of Dr. Nitin Karmalkar, Vice Chancellor of Savitribai Phule Pune University, the National Service Planning Department is setting up a system at the university level for various types of relief and rehabilitation for flood victims. Due to the huge contribution made by Savitribai Phule Pune University, Pune and affiliated colleges in the flood situation in Kerala last year, we were able to reach out to the flood victims of Kerala. Due to floods in Sangli and Kolhapur districts this year, people's lives have been disrupted. Against this backdrop, collection of various items from Pune, Ahmednagar and Nashik districts, RTGS, net banking, checks, raising funds from all walks of life, creation of Hon'ble Vice Chancellor's Fund and disbursement of that fund to the flood victims. The National Service Planning Department has also set a target of participating in the actual rehabilitation work through student volunteers over the next two months.

Also, in some parts of Maharashtra, it has not rained yet and the situation is getting worse day by day due to drought. It is our duty to take care of the people there. We will carry out rehabilitation and relief work through various means in the drought affected areas. The affiliated colleges and institutes are being appealed accordingly,

1. Savitribai Phule Pune University has appealed to the citizens, business people and employees in the area to deposit the funds in cash or by check or through RTGS, Net Banking.
2. All the students from all the colleges and faculties affiliated to the university should make a contribution of at least Rs. 10/-.
3. All the teachers and non-teaching staff of colleges, ecosystems and university departments should hand over the minimum amount of Rs. 100/-.
4. The grains and other items collected by the colleges till date are sufficient and no one should deposit or buy anything other than the grains and other items or money from now on.
5. To encourage student volunteers to join the system of Savitribai Phule Pune University for actual rehabilitation within the next two months.

However, all colleges and institutes are requested to raise funds through the online system provided by Savitribai Phule Pune University for the relief of flood victims by students, parents, teachers, non-teaching staff as well as citizens, professionals and employees of the surrounding area. It is also being appealed that the aid should be collected in the next two weeks and brought to the notice of the university.

Sir/Madam,

Under Savitribai Phule Pune University, National Service Scheme, various activities of National Service Scheme will be implemented throughout the year with the help of 55,600 National Service Scheme volunteers in 479 colleges. As an integral part of this, it is mandatory for every college to organize 7 days special camps on behalf of National Service Scheme Unit. Accordingly, this year, each National Service Scheme unit is required to conduct these 7-day special camps from October 25, 2017 to December 25, 2017. Proposals are being invited from each National Service Scheme unit for these special camps. These proposals are being solicited online and from 13th October, 2017 to 22nd October, 2017, the National Service Scheme is required to submit online proposals. For this, a link of [www.unipune.ac.in/bcud/login/nss/special camp proposal](http://www.unipune.ac.in/bcud/login/nss/special%20camp%20proposal) is being provided.

As per the instructions of the Government of Maharashtra, the guidelines for the activities that need to be taken while conducting these special camps have been added once again. Strict adherence to the instructions is essential. While organizing special camps in the villages adopted by the NSS unit, it is necessary to conduct camps in those villages for at least 3 years as per the instructions of the Government of Maharashtra. According to his instructions, NSS needs to build his relationship with the village through various means and activities, not just for the camp.

Those who are not able to take special camps during the period from October 25, 2017 to December 25, 2017 should try their best to organize camps during this period. If this is not possible due to exceptional circumstances, they should organize special camps between December 25, 2017 and January 15, 2018, but the proposal, along with the appropriate causation, must be received online by the NSS office before October 22, 2017.

Last year, it was noticed that some NSS units did not organize special camps in the villages and as per the schedule announced earlier. Such units were issued a stern warning last year. This

year you are kindly requested that the national unit of your college should conduct special camps in accordance with the guidelines of the University, Central NSS Department and Government of Maharashtra and in the adopted village and as per the schedule announced by NSS unit. You should instruct your NSS unit and program officer that otherwise such persons will be subject to strict action as per the University Act and NSS instructions or the unit will be suspended for at least 2 years.

In the last one year, the National Service Scheme has received complaints from volunteers about NSS units, their procedures, lack of consistency in activities and holding of Jujabi camps. Of course, since these complaints were received after the camp period, it was not possible to ascertain this. Therefore, during the special camp period this year, NSS will be more carefully monitoring and evaluating each other's working methods, activities, planning and overall camps.

NSS unit is a small gurukula that teaches pride and social responsibility for college students. We all need to be more sensitive in this regard. It is therefore kindly requested that under your guidance the NSS unit should operate more efficiently and that your experience, administration skills should be of benefit to the National Service Planning Department of the University and also to the NSS volunteers and program officers in your NSS unit. As a result, it will be possible to make a different impression of Savitribai Phule Pune University in the NSS Department of Indian University.






